PURPOSE: The Hawkins Family Organization began in 1985. It is conducted by mail and has no scheduled meetings. We want to promote genealogical research on Hawkins families and related lines; to promote and share family history; and to strengthen extended family ties.

NEWSLETTERS: *HAWKINS HERITAGE* is published three times a year in April, August, and December. We encourage members to contribute material to the editor. It is preferable if you type your material, but if not convenient, please share it anyway. Write your name or initials on each page.

QUERIES: Members are also encouraged to send queries to the editor. Send enough to cover your questions. Please include siblings whenever possible.

MEMBERS AND SUBSCRIPTIONS: We began *HAWKINS HERITAGE* with the hope of identifying the parents of James and Margaret ? Hawkins, b. c1765 and 1768, probably in Virginia. Taxation records show that they lived in Stafford CO Virginia from 1793 until 1825, when they migrated to Clark CO Kentucky. One son, John R., married into the Hawkins/Bourne line, which may be a connecting branch of the above James. Because of an apparent need for group research, our publication is now open to descendants of all Hawkins lines.

Individual membership and subscription is \$12 per year. Contributing Membership and subscription is \$20 per year (may vote.)

Subscriptions begin with the April issue. Subscribers during the membership year may receive back issues of the current year or begin with the next year and pay for and single back issues, which are \$4 each. The 1st issue: December 1986; 2nd, April 1987; then three issues per year beginning April 1988 to current.

PEDIGREE SERVICE: You are welcome to send your Hawkins pedigree chart to be checked with our collection. You will be given any additional information which we might have on file, that would match up with your own. Your chart will be filed for possible future contact. Our ancestor files deal mostly with Hawkins of the south and southwest, but we do have some other areas. Cost of this service is \$1 to cover search and photocopies, plus SASE.

I don't have copies of the entire wills, but have listed the heirs and witnesses. That helps put family members together.

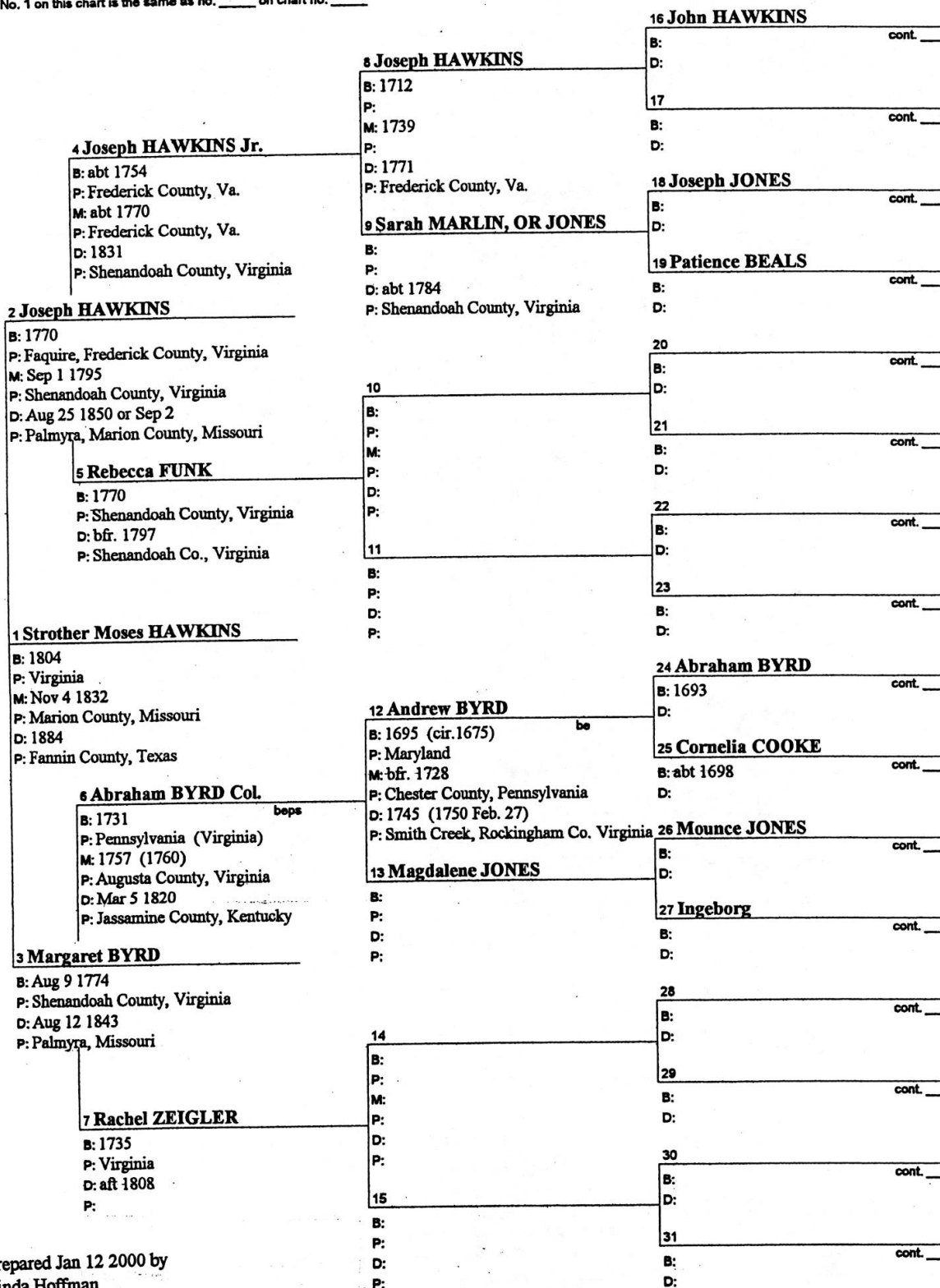

RECEIVE HAWKINS FAMILY INFORMATION FROM KENTUCKY

This is dated 9 July 1967

Copied from newspaper article

An official tombstone to John Hawkins (1757-1831) was unveiled Sunday, July 9 at the Three Forks Bacon Creek Church in Hart County, Ky. near Hammondsville. The stone was presented by the DAR. Descendants of the family bought a stone for his wife, Francis Thorp, which was also unveiled.

The program in the church included patriotic songs and the Life of John Hawkins, by Caroline Hawkins. An honor guard from Ft. Knox, Ky., led the procession to the cemetery and gave a presentation of colors. Remarks concerning the Revolutionary War soldier, lifting the veil and presenting the marker was by the DAR chapter. Acceptance and unveiling the wife's marker was by a descendant.

Some of the facts from his life story:

John Hawkins was a Revolutionary soldier, having enlisted at 16 years of age in the Militia of Capt. George Walls. He fought in the old Augusta County, Va.; today this is in West Virginia.

He was the son of William Hawkins and wife Jane Sharp and grew up in Fredrick County, Va.

There were 10 children in the John Hawkins family. They lived mostly in Hart County, Ky., as John came to this county when it was formed in 1819.

One of their 10 children was Coleman, the father of the Miller County, Mo., Hawkins family. Most of the 11 children of Coleman Hawkins and wife migrated to Miller County before 1840. He was married to Sarah Bonds.

A letter including the program for the day, The Life Story of John Hawkins, and a listing of descendants, was sent to Clyde Lee Jenkins for use in his History of Miller County. Mr. Jenkins made this information available for use in this paper.

Notes on Coleman Hawkins:

Coleman and Sarah emigrated to Hart Co., Ky from Va. in 1825.

They emigrated to Miller Co., Mo. sometime after that. Coleman

Led two groups from Virginia/Kentucky to Miller Co.

Most of Coleman's children emigrated to Miller Co. before 1840.

Son William emigrated in 1842.

(John) Coleman is listed in the 1850 census of Hart Co., Ky., page 208 #460, dated 5 Aug 1850, as residing with (Danl or Paul) Thorp who is listed as 26/m/farmer, wife Elizabeth 19/f, daughter Narcissa 9/12/f. Coleman is listed as insane.

Son Joseph Bond and Coleman are listed as members of the Hickory Point Baptist Church in 1843.

Coleman is listed in the "History of Miller Co., Mo." by Shultz, and is in the memoirs of Judge Jenkins of Miller Co., Mo.

Son-in-law Gabriel Thorp is listed as being KIA as a member of the Confederate States of America during the civil war.

Dear Sir:

Yours of the 11th reached me Saturday. I am glad to hear from you as I feel we are connection or if we are not we are of Hawkins birth. My father was named Wm. He was born 10th of February 1784. He moved from Kentucky to this state in the early settlement when people were living in Forts. He died in Howard County, MO the 8th of July 1845. I don't know the year he emigrated but in early times he emigrated from Scott County, from near Georgetown, he first settled in St. Louis then sold and came to Howard County, Mo.

My mother was named Lydia Todd Francis. I imagine she was born in Kentucky born 19th of May 1787. Married in Kentucky. I don't know the date but during the Revolutionary War. She died May 27th 1861. She died in Howard County Mo.

My brothers and sister were named: John Littleberry; Wm. Johnson; Granville Francis and Mary Jane. My sister married Benjamin Cason. I am the only one of the family living. Brother Wm; his daughter the only child named Judith Francis wife of John D. Cason, Pomona, California. Sister Mary wife of Benjamin Cason. One child died without an heir—brother John and Granville never married.

My wife is dead. We had five children. William Reason; Mary White, Sarah Catherine, Judith Francis and John Franklin, all living but John. There is none of them married. My children all live with me. I have no tradition as to where my Grandfather was born. I have no tradition as to whether he served in the Revolutionary War or not, but all men had to without an excuse, especially of his age.

I know of no other members of the family. I am sixty-seven the 10th of September next, born in the year of our Lord, Eighteen-hundred and twenty-five. I have no record of any kind concerning John Hawkins and wife. I would be glad to make your acquaintance. I would be glad if fate should went our way in each others pathway.

Dear Sir:

Your letter of the 13th, inst, 6- Mar. Henry S. Lane, has been handed to me for an answer.

My mother (now in her 77th year) Willey Belfield Jameson (a sister of Pamila Bledsoe Jameson Lane, who married Henry S. Lane) is a daughter of Thomas Jameson Jr., son of Thomas Jameson Sr. (I think the latter was Jr. before the birth of his son) a brother of your great grandmother Margaret Jameson.

We have no definite information as to the name of our great grandparents' fathers' given name and would be glad to know the source of your information that his name was Thomas, nor have we any information as to whether he was a soldier in Revolutionary War. I am now seeking information upon this and all other matters pertaining to my ancestry – Jamesons, Bourne, etc. My mother gives me the following list of her grandfather's family – i.e. himself and brothers and sisters, but names not given according to age.

Thomas Jameson – married Judith Ball Hackley

James Jameson – Married Lucy Hackley

David Jameson

Margaret Jameson – married March 1767 to John Hawkins

Dorothea Graham Jameson married Ayers.

She does not know that there was a John, but that is a family name.

My father Walker Bourne was born in Culpeper Co, VA in 1790, moved to Kentucky in 1802. He told me he had often seen John Jameson and David Jameson. Has said David was either a major or a colonel in the War for Independence; and that John was an officer, I think in Madison County, VA, a six footer, blue eyes, black hair and one of the finest looking men he ever saw. I do not remember what he stated was their relationship to my mother.

My great grandfather Thomas Jameson and my grandfather Thomas Jameson are buried at the old family home of the first, in Montgomery County, Kentucky, where the latter was born in 1783 – the oldest of the family.

Great grandfather moved to Kentucky in 1782, died August 14th, 1827, aged 84 years.

Uncle Henry S. Lane said that he thought that Tom Jameson father of Patrick Henry Jameson was a distant relative of ours. Please write me the source of your information that Gen'l

Jameson's grandfather was a half brother of my great grandfather; and also that your great grandmother had a brother names John; also give me all the information you can about family.

I have a letter before me written by David Jameson, Jr. from Caroline (Va.) May 13, 1795 to Samuel Ayers, who married Dorothea (Dolly) Jameson. Aunt Ayers was born at Yorktown, Va. July 27, 1768. Married Wednesday October 1792, died April 18, 1848. She was educated at Williamsburg, Va. Her grandson William Ayers of this city has shown me her "cyphering book" used at school in 1780, and some splendid penmanship in it and another book which their tradition says was done by my great grandfather Thomas Jameson.

My mother informs me that John and Margaret Jameson Hawkins had but one son, Jameson Hawkins and his children were "Jack" Hawkins, Mrs. Sanders and others. My mother went to Crawfordsville, Ind in 1836 and whilest there saw "Jack" Hawkins and his children among them the one who married General Canby. Presuming that you are one of the children, I suspect she saw you. General Canby's sister Sarah was an attendant of my mother when she married my father in Crawfordsville in 1837. Two of your sisters I presume married Speeds.

My grandfather James Bourne was a soldier of the Revolution, and like yourself I have deferred joining the Sons of the Revolution till I had learned this history of my Jameson ancestry, and for the same reasons you gave.

My father was a soldier in the War of 1812 and in the battle of the Thames and was near where Tecumseh was killed. I was in our late war. In the 5th Kentucky Inftry., 1st Ky. Brig. C.S.A.

I have a letter from Cousin Mary Crouch, daughter of James Jameson, son of James Jameson's brother to your great grandmother Margaret Jameson. Cousin Mary returned a few weeks ago from a visit to her California relatives; she expresses her regrets that she did not know of your relationship and presence in San Francisco. She furnishes me the following information as to our relatives living in California, all of whom will be glad to see you.

Mrs. Crouch's brother, James S. Jameson, resides at #1180 19th Street, Oakland, Cal. And his business office is at 14th and Townsend Streets, San Francisco, freight Office of the S.P.R.R. Mrs. S. J. Crow, daughter of Margaret Jameson (who married David Steward) daughter of Thomas Jameson who was brother to your great grandmother, resides at #220 South 9th Street, San Jose. Mrs. Steward was doubtless named for you great grandmother. A deceased brother of Cousins Mary Crouch and James Jameson died leaving a family in Eureka, Humboldt County, Cal., a son and two daughters. Cousin Mary has a son James Crouch in Santa Cruz County, farming.

Hope I have not made my letter to you so long as to be tiresome. I will be thankful for any information you have or can obtain as to genealogy and residence of any of our relatives, date of birth, etc., etc.

I shall now press the matter of investigation of service of our great great grandfather Thomas ? Jameson. Our great Aunt Ayers named one of her sons Thomas Robinson Jameson

Ayers and as the Ayers side of the family cannot find that they had any Robinson relatives I think there is justification for the inference that he (our great great grandfather) was named Thomas, and that his wife was a Robinson – the latter inference because David Jameson Jr. in his letter of May 13, 1795 to Mr. Ayers says he hoped to soon be able to forward the money from the Speaker Robinson Est.

My mother informs me that a Thomas Jameson visited Kentucky at an early day who was called “Virginia Tom” to distinguish him from mothers grandfather who had then become a resident of Kentucky. Virginia Tom was reared in wealth and was wild and reckless and married his Kentucky kin. He died without issue.

All the records at Richmond, Va, having been destroyed by fire in April 1865 we will have to depend on records elsewhere on tradition for the information we seek. I shall correspond with persons in Virginia and try to find out, but you know the region from which our people came was the seat of many campaigns in our late war and all records may have been destroyed. I shall however do all I can in that direction.

My great grandfather Thomas James married a cousin of George Washington on Ball side, so even without finding the information we seek, I am on my mother’s side a blood relative of the chief rebel of the Revolutionary War.

Your Kentucky kin would be glad to see you whenever you can visit them.

Remember me kindly to such of our relatives as you may see in California. Higgins Lane, brother of Henry S. Lane married a lady who bore the same relationship to you that my mother does.

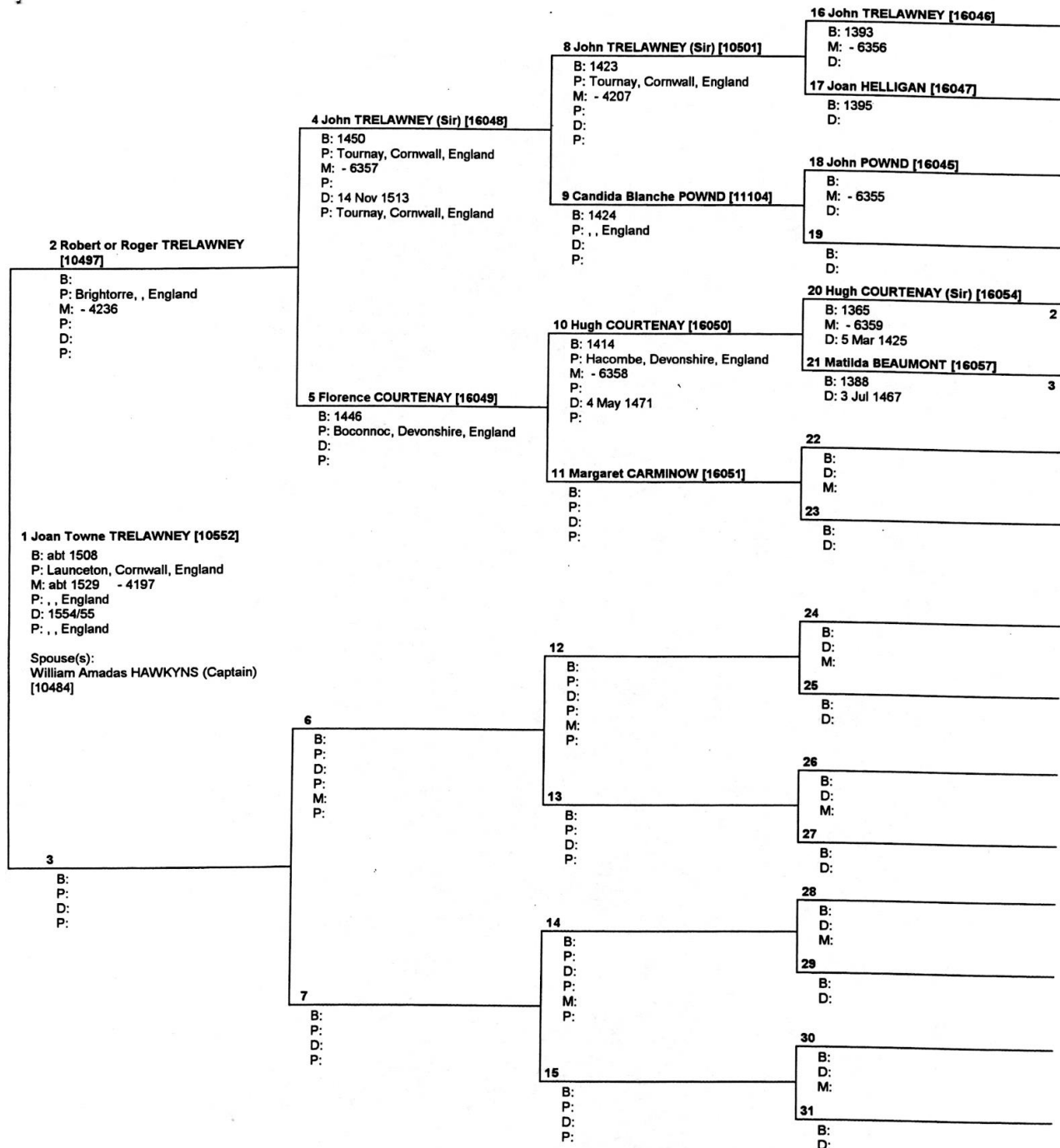

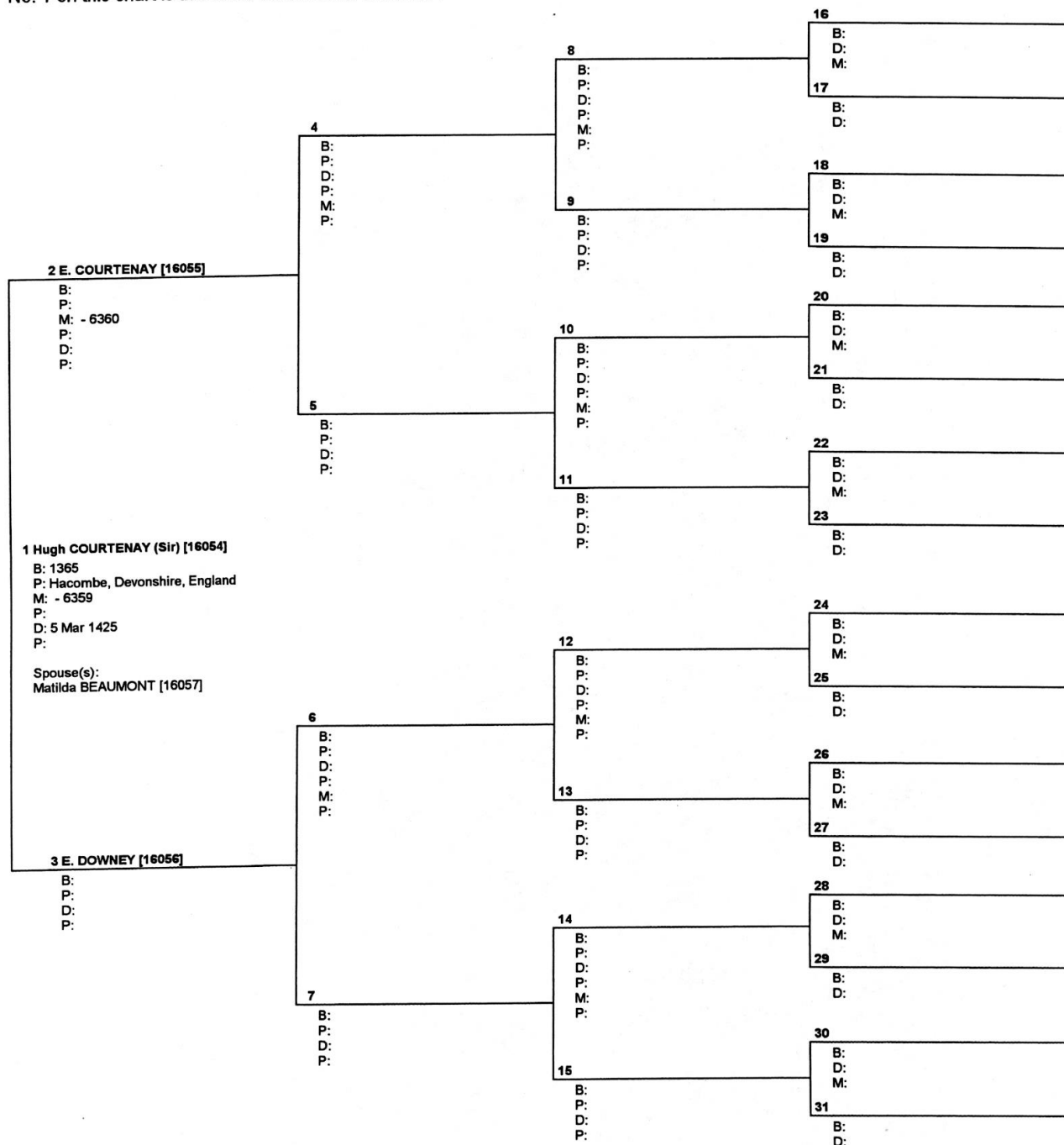

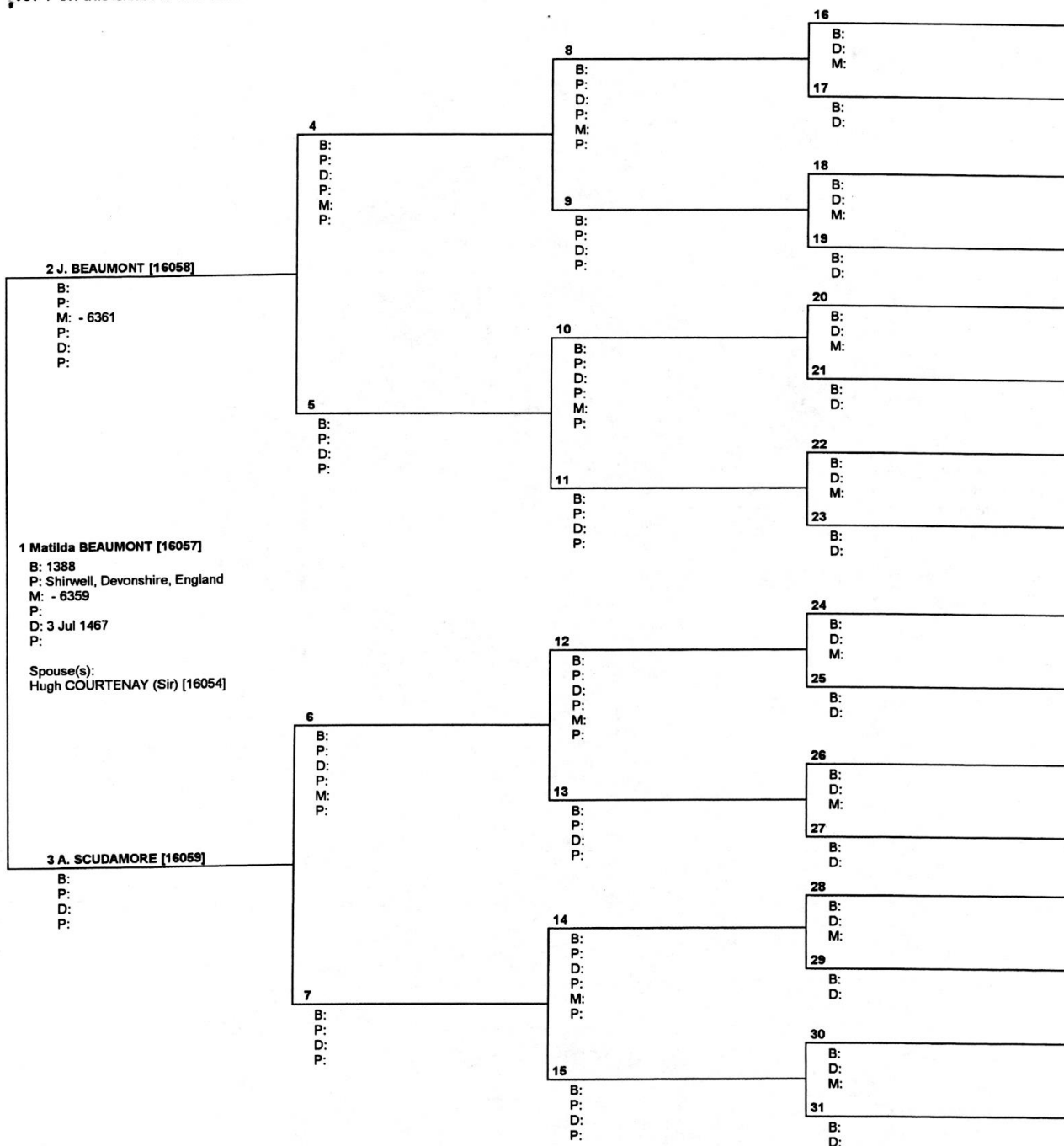

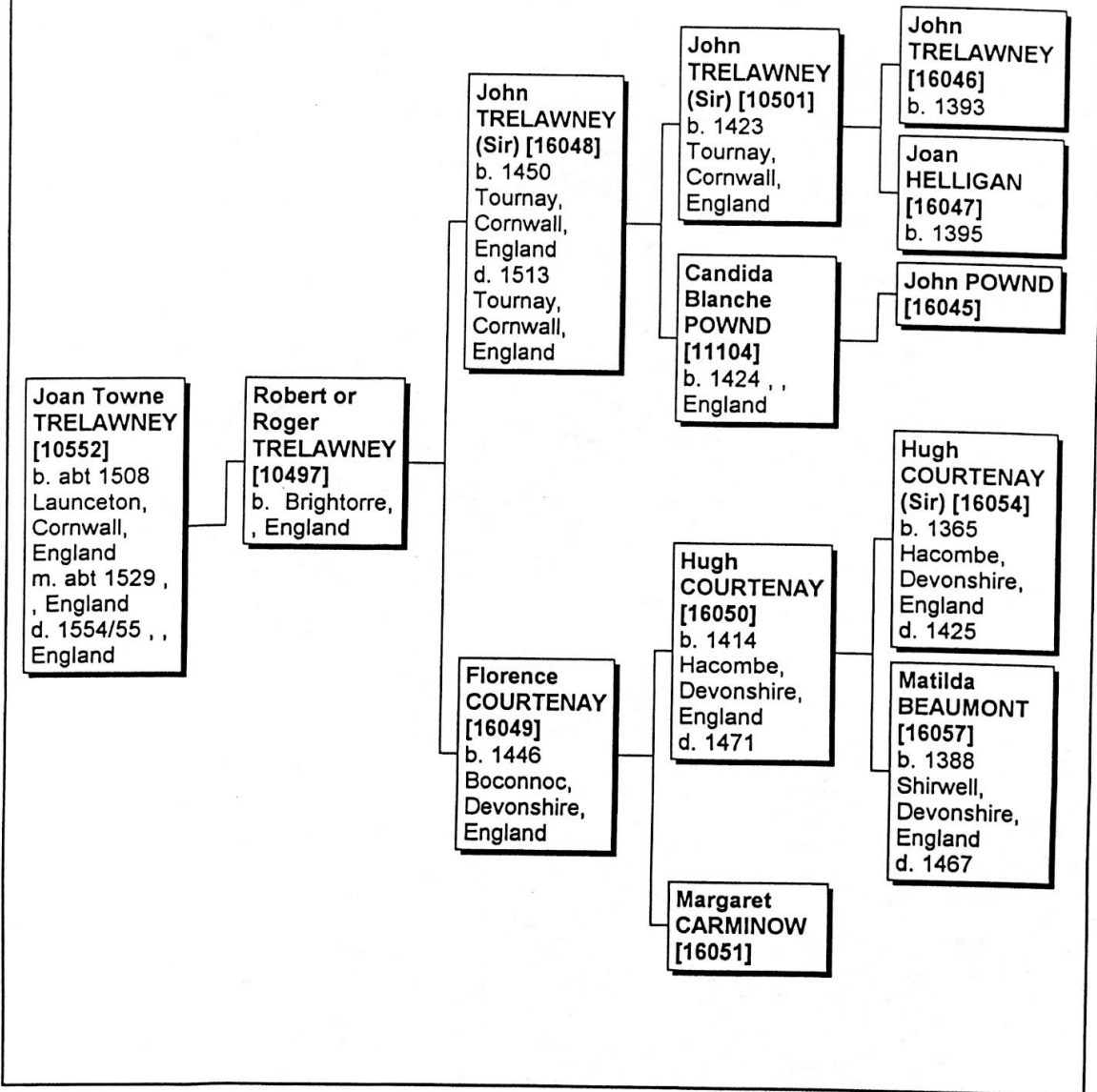

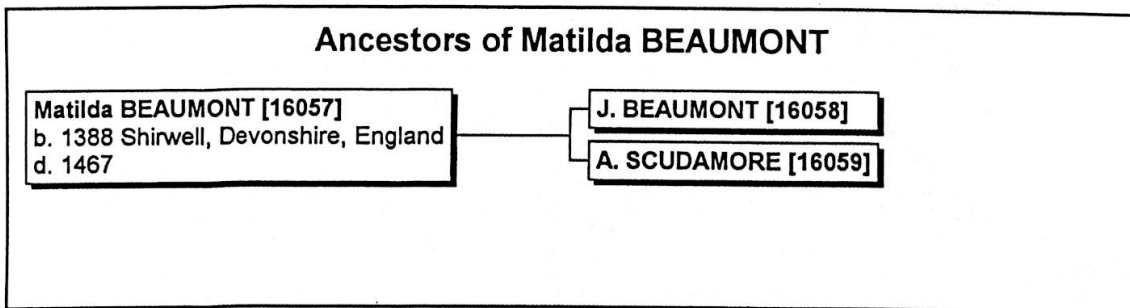

DON'T SPATTER THE SYRUP

A mule and a kettle

"Giddy-ap, Zelda." The old mule was a work-horse all right. She had her work to do.

Many farmers marked off a section in which they grew a small amount of sugar cane, but did not consider it a major crop. While the cane still stood, workers walked through the rows and "topped" it. Topping it before cutting it down simply eliminated a later step, speeding the process. They bent the stalk, removing the seeds in one stroke of the knife, and when ground, it could be used as feed.

Back to Zelda. The mule, tied on a rope attached to a log, circled round and round the mill press, providing power to press juice from the sugar cane. When the mill continually pressed the juice out, it dripped into a big tub or kettle, where it boiled down to syrup.

In communities of the late 1800s, many people did not have a mill press, so they crushed the cane with hand tools, and boiled the sugar sap in a big black kettle. Stir, stir, stir . . . Sneak a taste with a long stick.

Parents cautioned the children to take care when inserting a stick into the hot liquid, as it could easily spatter on them. On one occasion, a distant cousin put the water dipper into the syrup. As he walked away he tripped and spilled it, severely burning his foot and ankle.

After the juice boiled down, it was poured and strained. Adults as well as the kids enjoyed the "stir-off," making a party out of the entire process. They all liked to chew the end of a piece of sugar cane, hoping to get its sweet juices.

Great-Grandfather Andrew Jackson Hawkins owned two black pots in which to pour the sap. He constantly stirred it over a highburning fire. His daughter Anna Kate wrote to her sister in 1892, "Uncle Jerry and the boys will be over to help with the stir-off. We are all anxious to see everybody and to make molasses. It has been too long since we did either."

It rarely snowed in Texas during these stirring-off events. But in New England at "maple sugar time," the people treated themselves to hot maple syrup poured over a bowl of snow. Once the syrup hit the snow, it hardened and they ate it like candy. Now that sounds good.

The antique black pot on our patio might have once felt hot syrup within its sides, but now it is filled with moss rose.

9. Put your name on *every* page you send.
10. Please put the date on your letters as well as on the material you submit. It is helpful if you use an inside address on your letters. I file your letters but not the envelopes in my notebooks.
11. If you are a new member, we hope you will send a family group sheet or pedigree chart.
12. We urge our members to send queries. You may do this once a year, and they can be in "standard" form or in letter form. It may be helpful to print it again since we have new members all the time.
