On this 16th day of July, 1867, personally appeared before me, the undersigned, Clerk of the District Court, in and for the County and State above named, which is a Court of Record, (1) Nicholas Warshan who being first duly sworn according to law, deposes and says that he resides at Dayton in the County of Chickasaw State of Iowa and is aged 82 years, and that he is the Father of (2) Emanuel Warshan who was a (3) Private in Company "B" of the 3d Regiment of Minnesota Volunteers Infantry in the civil war of 1861-5, for suppression of the Rebellion against the United States Government. That h<sup>e</sup> said Son was mustered into the military service of the United States at Nabashaw, Minnesota on or about the 15 day of March A. D. 1864; and that he died at New Hampton in the County of Chickasaw and State of Iowa on or about the first day of October 1864; by reason of Chronic Dysentery contracted while in while in the service of the United States, and in the line of his duty, and that he left no Widow, Child or Children or \_\_\_\_\_ surviving him. That he has not in any way been engaged in, or aided or abetted said Rebellion. That he is not now in receipt of a Pension under any act of Congress, and that he makes this declaration for the purpose of being inscribed on the Army Pension List, under "An Act to grant Pensions," approved July 14, 1862, and the acts supplementary thereto, to commence on the \_\_\_\_\_ day of \_\_\_\_\_ 186  . he requests that he be inscribed on the Roll of the Dubuque Iowa Agency. That Post Office Address is New Hampton County of Chickasaw State of Iowa, and he hereby constitutes and appoints Tucker & Sell Washington of Ia. his Attorney to prosecute this claim and procure a Pension Certificate.

On the same day personally appeared \_\_\_\_\_ and John May \_\_\_\_\_ persons who are well known to me and whom I certify to be respectable and entitled to credit; and they, being sworn according to law, declare that they were present and saw Nicholas Warshan sign h<sup>e</sup>s name to the above application; that they are not near relatives of said applicant, and have no interest in h<sup>e</sup>s claim nor in the prosecution thereof; that they are residents of New Hampton in the county of Chickasaw and State of Iowa; that they have been acquainted with said Nicholas Warshan and h<sup>e</sup>s family and their pecuniary circumstances for the past ten years; [(4) that they know that he is (5) \_\_\_\_\_ of (6) \_\_\_\_\_ day of \_\_\_\_\_ A. D. 186  ;] and that he is the Father of said Emanuel Warshan who entered into the Military Service of the United States and died as stated in h<sup>e</sup>s said Declaration.

That they knew the said Emanuel Warshan and that he died leaving no wife or child surviving him, and that his Father was supported mainly by the said Son, before and after his enlistment into the said Military Service. That said applicant's present means of support are as follows: he has personal property, worth in our estimation Eighty Dollars, consisting of one cow and two two year old horses

That, as to said applicant having been wholly or in part supported by h<sup>e</sup>s said Son, and his contributing of his time, or labor or earnings towards h<sup>e</sup>s support, or supplying him with necessities before his enlistment, and sending portions of his pay to him after his enlistment, the facts derived from the deponents' knowledge thereof and their acquaintance with said applicant and h<sup>e</sup>s family, are as follows: (See two affidavits hereto attached.)
