bapt. date of 20 April 1777.

II. Mary Ashley d. 26 July 1895; will dated 14 April 1874; pro. 20 May
1897 (Hastings Co. Surrogate Ct. #2088-1897-Belleville) Execs.
were her sons Jacob Meyers Ashley & Henry Wonnacot Ashley. Her
will also named sons George Calvin Ashley; and John Ashley to have
only \$10 "in consequence of his misconduct".

She also named daus. Augusta Matilda Ashley; Sarah Ann Eliza Ashley,
now wife of Charles Parkhurst; and Caroline Ashley, wife of Richard
Taylor.

Did they also have a son, James B. Ashley, whose estate was in
Hastings Co. Surrogate Ct. #1755-1894-Belleville?

The Searchlight-Spring 1991, V.II, #1, from Quinte Branch

not named, found the name as Charles, as Edward, and as Ted,
on various recs., but I have found him only as Charles.
He was son of Henry Corby, Sr., and his 2nd wife, Matilda
Williams. The article says they left Canada in 1883, and
he worked in NY, and in Chicago, IL, before settling in
Seattle, WA. He is called a manufacturer in the 1881 census.
In Seattle he went into the manufacture and sale of canned
fish products, controlling many canneries in Puget Sound
and Alaska. His business was known all over the world, but
especially in U.S., Can. Gt. Britain, China, Japan, Australia,
New Zealand, S. Africa, and parts of Europe.

He was a member of St. Mark's Episc. Ch. in Seattle, the Blue Lodge Chapt. & Council, A.F. & A.M., and the Scottish Rite bodies of Masonry.

Family of Elizabeth Waldemeier, the 2nd child and eldest dau. of George Waldemeier, Sr., and his wife, Margaretha.

Elizabeth Waldemeier was b. 26 March 1747; bapt. 8 April 1747 at St. Peter's Luth. Ch. (Stone Ch.), Rhinebeck, Dutchess Co., NY; sponsors-Leonard Wager & his wife, Barbara. d. perhaps bet. 1800-1803, as she wasn't ment. in her husband's will in 1803. (1790-1800 census)

m. 27 July 1766 at St. Paul's Evang. Luth. Ch. of Wurtemberg, Rhinebeck, Dutchess Co., NY, John Garrett, son of Thomas, both of Great Nine Partners in Dutchess Co., NY. She was called dau. of George. (I found the orig. m. rec. at Clinton House in Poughkeepsie, NY, in the late 1970's or early 1980's, but when I wanted to check it for other family names in 1991, it had disappeared. Noone seemed to know what had happened to it. I recently learned that it is supposed to be in the Manuscript Div. at the State Lib. in Albany.)

John was b. bef. 1755; prob. in the 1740's or earlier.

He d. July or August 1803 in Greene Co., NY; will dated 25 July 1803; entered for pro. 29 August 1803; reg. 3 September 1803.

They were in Coxsackie in 1790-1800. It was in Albany Co. in 1790 and in Greene Co. in 1800.

Hist. of Greene Co., NY, p.371, says John Garrett, of German descent, came into New Baltimore a short time before the Rev. War and settled a short distance west of Kalkberg. After his d., his youngest son, Levi, remained on the old homestead. (I'm sure the last sentence is an error. John does not name a son Levi in his will. In John's will, his son, John, receives the "homestead". Simeon Garrett, who may be John's bro. or cousin, does name a son, Levi, in his will. Since there is only one Levi in the area in the census, I believe he belongs to Simeon, but he is not Simeon's youngest son. He appears 1st in Westerlo, Albany Co., but after Simeon's d. he is in New Baltimore, Greene Co., where Simeon had settled. Simeon's will does not specify who receives his homestead, perhaps because his wife, Abigail, is still living. Levi may have taken over after their d.)

Since several of Elizabeth's children were bapt. at Coxsackie, and no other John Garrett is ment. in that time period, I believe the family there in 1790 & 1800 is the correct family for John & Elizabeth. That part of Coxsackie became New Baltimore 15 March 1811.

A list of Capt. Henry VanBergen's Co. from the above Hist. of Greene Co., p. 238, 1777, inc. the names of John, Samuel, & Isaac Garrett. p. 237 had an assessment roll for the area for 1787. It inc. the names of John, Simeon, & Isaac Garrett. John may have had bros. or cousins who lived in the same area, but only Simeon continues to be listed until his d. bet. 1842-1847.

Children: (In John's will he named sons Ephraim, John, Mikle, & Jacob; and daus. Elizabeth & Molly. Elizabeth had a son bef. her m. to John.
