Family of Jurien/George Waldemeier and Margaretha Bardin

See Family of John Walden Meyers and Mary/Polly Gruber/Kruger, by Mildred (Shores) Sussell, V. I, and V. II, for as much as I have been able to learn about George & Margaretha. I will list their children here, and tell more about them in the following pages.

Children:

- John- b. 24 February; bapt. 24 March 1745 at St. Paul's (Zion's) Luth. Ch. of Red Hook, Dutchess Co., NY, as Johannes/Hans Waldemeier. He changed his name to John Walden Meyers to escape detection as a Loyalist spy.
- Elizabeth- b. 26 March; bapt. 8 April 1747, at St. Peter's Luth. Ch. (Stone Ch.), Rhinebeck, Dutchess Co., NY.
- Johan George- b. 22 May; bapt. 11 June 1749, at St. Peter's Luth. (Stone Ch.) He became known as George, Jr.
- Catherine- b. 13 July; bapt. 26 July 1752, at St. Peter's Luth. Ch. (Stone Ch.)
- Jacob- b. 12 July; bapt. 21 July 1754, at Ref. Ch. of Rhinebeck Flatts, Dutchess Co., NY.
- Barbara- b. perhaps bet. 1856-1858. (I haven't found a rec. of her b. or bapt., but she is ment. in her father's will.)
- Michael- b. perhaps ca. 1860 (from age at d.). (I haven't found a rec. of b. or bapt. for him, but he is ment. in his father's will.)
- David- b. 29 December 1762; bapt. at St. Paul's Luth. Ch. of Wurtemberg, Rhinebeck, Dutchess Co., NY.

Family of John Walden Meyers and Mary/Polly Gruber/Kruger

- viii. Jacob- bapt. 20 April 1777, as Jacob Waltemyer, at Loonenburg Zion Luth. Ch., in then Albany Co., now Greene Co., NY.

The bapt. rec. said, "She swore the child to David Seger before Esq. Lister". John Waldemeier and his Frau, Mary, were witnesses. His family was covered in V.I, and V.II, so I will just list his children here.

- ii. Elisabeth Garrett b. ca. November 1767; bapt. 1 January 1768, age 6wks., at St. Paul's Luth. Ch. of Wurtemberg, Rhinebeck, Dutchess Co., NY; sponsors-Bastien Weger & Catherine Waldemeyer. She was still alive in 1803, as she was ment. in her father's will. She may have m. bef. 1790, as it is prob. the 2 youngest daus. who are with the parents in the 1790 census, unless they d.y. (The father's will ment. the daus. only by first names.)
  
- iii. Molly Garrett bapt. 7 (or 17) January 1773 at St. Paul's (Zion's) Luth. Ch. of Red Hook, Dutchess Co., NY; sponsors-George Proper & wife Berbel Diederick. She was still alive in 1803, as she was ment. in her father's will. She may have m. bef. 1790, as it is prob. the two youngest daus. who are with them in the 1790 census, unless they d.y. (The father's will ment. the daus. only by 1st names.)

iv. Ephraim Garrett bapt. 29 October 1775 at Coxsackie Dutch Ref. Ch., then Albany Co., now Greene Co., NY; sponsors-Leendert Feyer & Catherine Voll; d. after 1830 (1790-1830 census)

I am suggesting 3 possible marriages for Ephraim, although Hannah Miller may have been his only wife. Census takers often erred.

d. perhaps bef. 1800.

Ephraim is in the 1800 census with a f. und. 10 and no adult f.

Hannah, who was his wife by 1816, unless the census taker erred in the col. in which he placed the wife.) (1810 census)

m. perhaps (3) bef. 1816 Hannah Miller, eldest dau. of Jonathan & Lydia; b. 2 November 1777; d. after 1830 (1820-1830 census)

Hannah is his wife by 16 September 1816, when her father's will is pro., as she is called Hannah Garrett then. I believe that she was also his wife in 1810, and the census taker erred, as I believe their oldest son, b. ca. 1800-1804, is the Jonathan Miller Garrett ment. in his gr.father Miller's will.

Hannah does not appear in her parent's home in 1800, so she may have been m. to Ephraim by then and been absent from the house for some reason the day the census was taken.

They lived in Coxsackie Town, Greene Co., NY in 1800 & 1810, and in Coeymans, Albany Co., NY, in 1820 & 1830.

- v. John Garrett, Jr. bapt. 5 July 1778 at Coxsackie Dutch Ref. Ch., then Albany Co., now Greene Co., NY; sponsors—John & Barbara Coenly; d. bet. 16 October 1838 (date of will)—6 June 1842 (date will entered for pro.) (prob. bet. 1840-1842, as he was in 1790-1840 census)  
 m. ca. 180\_ Catherine . . . b. ca. 1783; d. after 1850 (1810-1850 census) (She was named in her husband's will.)  
 Children: (John's will named sons Frederick, Peter R., Ransom, Leonard, & John C.; and daus. Catherine, Emeline, & Caroline, not yet m.; and Arminda Baker, wife of Joab; Eleanor Requa, wife of Henry M.; and a dau., dec. who left children surnamed Miller (Her bro., Leonard identifies her as Elizabeth Miller, dec.)
- I. Elizabeth Garrett b. ca. 1804-1810; d. bef. 1838. (1810-1830 census) (I believe she is the oldest.)  
 (One source said she m. Jonathan Miller, and another said she m. Daniel S. Miller. She was not wife of Jonathan Miller, Sr., or Jr., so I believe she  
 m. ca. 182\_ Daniel S. Miller, perhaps youngest son of Jonathan & Lydia; b. bet. 1790-1800; d. perhaps bef. 1838; (1800-1830 census)  
 Elizabeth is identified in her father's will in 1838 and her bro., Leonard's, will in 1846 as dec. The gr.father's will stated that her 2 children were to have a home with their uncle, Leonard, until they become of age, so I believe their father had d. by 1838 also.

- A. Jonathan Miller, Jr. b. prob. 1825-1830; d. (1830 census) He was prob. called "Jr." to distinguish him from an older Jonathan. His gr.father was d., but his Uncle Jonathan was still in the area. I have not located him on a census since 1830. Called of Westerlo in 1846.
- B. Catherine Antoinette Miller b. ca. 1828; d. after 1850 (1830 & 1850 census) Called of Coeymans in 1846. She was with her gr.mother Garrett in New Baltimore, Greene Co., NY in 1850.

(1820-1830 census)  
Prob. unmarried; no wife ment. in will.

(I'm sure this should read "Lourens & Catherine Tiel", as Catherine was her mother's sister, m. to Lawrence Tiel/Teal.) d. prob. bef. 1800, as she was not in the 1800 census, nor was she ment. in her father's will in 1803. (Is it possible this was an illegitimate dau. of the oldest dau., Elizabeth? Only the mother, Elizabeth, is named on the bapt. rec. On all other bapt. both John and Elizabeth are named.)
- viii. Jacob Garrett bapt. 20 February 1785 at Coxsackie Dutch Ref. Ch. in then Albany Co., now Greene Co., NY.; sponsors—Jacob & Margarita Waltermeyer; d. bef. 24 December 1863 in Durham, Greene Co., NY; will dated 18 September 1858, with a codicil dated 8 May 1861; entered for pro. 24 December 1863; proved 28 March 1864.
