Family of George Waltermeyer, Jr., the 3rd child and 2nd son of George Waldenmeyer, Sr., and his wife Margaretha

- b. 22 May; bapt. 11 June 1749 as Johannes Georg Waltermeyer at St. Peter's Luth. Ch. (Stone Ch.), Rhinebeck, Dutchess Co., NY; sponsors—George Benner & wife, Gertrude.
- d. 23 October 1817, age 68y.4mo.12da.; bur. in the churchyard of St. Paul's Evang. Luth. Ch. of Wurtemberg in Rhinebeck. The inscription on the g.s. reads "John G. Waltermier who was born 11 June 1749", but he was called George, Jr., on most recs., and 11 June was his bapt. date. He mentions "daus." in his will, but doesn't name them, except for the youngest, Lydia, and Elizabeth, who was to receive land in Clinton rather than in Rhinebeck. His father willed him his German Bible. He lived in Washington Town in 1790 and Stanford in 1800 & 1810, Dutchess Co., NY. (He prob. didn't move, but the town was divided.)

She Q.C. her dower right on property George had inherited from his father. George's will states that his son, George, is to maintain his wid., Lydia, and the child, Lydia A., who is to inherit her share when she becomes 18. (This is prob. the "Clidea" named on one printed rec.—prob. a case of misreading an "L" as "Cl".) All of George's children were to share equally in the lands he owned in Rhinebeck, except his dau., Elizabeth, who was given land in Clinton.

III. William Waldemier b. 2 September 1816; bapt. 1816 at St. Paul's Luth. Ch. of Wurtemberg; d. bef. 1900 (1820 & 1840 census)
He lived in Milan in 1840. A child was bur. in St. Peter's Presby. Cem. in Spencertown in 1870. He was ment. in his mother's will, and also in the will of his bro., John.

m. bet. 1830-1838 Maryette Lucretia Webster b. November 1817; d. after 1900 (1840 & 1900 census)

In 1900 she was living with her son, Richard C., in Austerlitz Town, Columbia Co., NY.

He is prob. the one who built the Lafayette House in 1837, 13 years after Lafayette visited the area. It was in the town of Milan, on the main road from Ancram and other business places to the Hudson River. He built the hotel—a 2-story structure with an upper and lower stoop running across the entire length of the frontage—to accommodate the travelling public and also as a summer resort for people who wanted to escape the heat of the cities. He conducted an extensive business there for 10 years. (Hist. of Dutchess Co., NY-1683-1882)

Ch. of Wurtemberg calls this Elisabeth "wife of Jacob P." and gives his d. date as 2 July 1821, age 67y.11mo.7da., which would make his b. date 26 July 1753. There must have been another Jacob P. Traver in the area, as there was another one in the census whose age doesn't fit, and one in the 1830 census, after both Elisabeth and Jacob are dead.
