b. 29 December 1762; bapt. at St. Paul's Luth. Ch. of Wurtemberg, Rhinebeck, Dutchess Co., NY; sponsors-David Seger & Gertrude Pultz. (The Ch. was organized in 1760, so he was the 1st Waltermeyer child bapt. there.)

d. 8 May 1854, age 91y.4mo.10da.; will dated 9 March 1850; pro. 10 May 1855; bur. Waldenmeyer Ground, Town of Stanford, Dutchess Co., NY.

He settled in the Town of Stanford. He was a farmer.
