I am seeking all genealogical and biographical details for the family documented below including their ancestors, children, and grandchildren and the spouses thereof, including the full names of those spouses' parents. All additions and corrections within this scope, however speculative, will be greatly appreciated.

Stockdale Coddington of Hampton, New Hampshire

The Coddington family represents one of the most challenging lines of research in which the compiler has been involved. To date, it has proved impossible to link John Coddington, our earliest known ancestor, back to an immigrant. This task seems even more daunting when one learns that the eminent genealogist, John Insley Coddington, was also unable to achieve this goal. Well known for his countless contributions to *The American Genealogist*, he published an article in that journal on the compiler's family entitled, "An Unconnected Coddington Family" ([32:84] hereinafter *TAG*). Although our exact connection to an immigrant ancestor remains unknown, the available evidence suggests that we belong to a Coddington family that migrated from England to Massachusetts, to New Jersey, and on to New York. Given our probable descent from this family, the early generations of this Coddington family have been included below.

 John and Hannah (Gardner) Coddington migrated from Massachusetts to New

The compiler's earliest known Coddington ancestor was John. Nothing of his parents is known; however, it is widely accepted that he was the younger brother of Benjamin Coddington. Given the great disparity in the years of the birth and the fact that they were born in different states, I am not convinced of that they were so closely related. Benjamin and John may have been half-brothers, uncle and nephew, cousins, etc.

From records cited below, we know that John was born in New York State about 1778. Assuming that his father was still alive in 1790 and that he remained in New York State, he was

probably one of the Coddingtons enumerated in Ulster County, New York in the first federal census. In 1790, the majority of Coddingtons within New York State were residents of Ulster County.

JOHN CODDINGTON, born in New York (1880 Federal Census, Hector, Schuyler County, New York [birthplace of Mary Ann (Coddington) Coddington's father]) about 1778; died at Hector, Schuyler County, New York on 12 August 1845, "aged 67." John was first married about 1797 to Mary Ann Robinson, born in Ireland (1880 Federal Census, Hector, Schuyler County, New York [birthplace of Mary Ann (Coddington) Coddington's mother]) about 1779. John married second, ELIZABETH ___, who survived him.

At one time, it appears that the eminent genealogist, John Insley Coddington, erroneously felt that John was the son of Christopher and Maria (Osterhout) Coddington:

First records of the Coddington family are not dated. All that is known is that Benjamin Coddington, Jr. married Katherine Martin in Woodbridge, New Jersey. They had a son named Christopher born in New Jersey (whether or not it was in Woodbridge is not known) who married Maria Oosterhoudt in Rochester [Accord, Ulster County], New York, October 13, 1753. Their son, John Coddington, was born in 1778. He married Mary Ann Robinson and died at Hector, New York, July 12, 1845. (*Family Records conveyed in correspondence with Douglas R. Tripp*, hereinafter *Tripp FRs*)

In 1997, the compiler was able to locate a copy of *Osterhout* (Distributed by the Ulster County [New York] Genealogical Society). In this genealogical outline of the descendants of Jan Jansen van Oosterhoudt, is found the family group of Christopher and Maria (Osterhoudt) Coddington. However, their son, John, was born in Deer Park, Orange County, New York on 14 April 1765. Although it is quite possible, if not probable, that John was born in Ulster County, he was not the son of Christopher and Maria (Oosterhoudt) Coddington.

By 1800, John had settled in Cayuga County (1800 Federal Census, New York State, Cayuga County). Mary Ann became a member of the Baptist Church at Covert on its founding, 16 February 1803; John joined shortly thereafter on 20 February 1803.

Their marriage on 24 January 1822 by the Reverend O.C. Comstock was recorded in *The American Journal* of Ithaca on 30 January 1822: "Calvin Coddington of Hector to Miss Sarah Porter of Ulysses."

[Calvin and Sarah] moved later to the town of Howard, Steuben County, [New York] where Calvin was apparently engaged in clearing timber land. He was accidentally killed by a falling tree late in December, 1836, and his body was not found by searching parties for three weeks, or some time in January, 1837.
